24. BRIEF DESCRIPTION OF PROJECT AND RELEVANCE TO THIS CONTRACT *(Include scope, size, and cost)*

The facility contains 147,000 SF of Offices and Warehouse space and is used primarily for supplying Robins Air Force Base with base-related material. Warehouse areas include segregated areas for bin and rack storage of depletable supplies and non-depletable equipment. A secured WRSK Storage area is also provided with drive through truck access. A separate area is provided for the Individual Equipment Unit where uniforms are distributed. A separate entrance and merchandise display area allows visitors access without entering the main building. For durability and maintenance, CMU and brick masonry is used from the ground to the 7 foot level. Site Development included the relocation of Peacekeeper Way. Landscaped parking is provided for 380 automobiles. The Design package (C.I.D.) included 315 pre-wired work stations and furnishings selections for government bidding. The 45,000 SF two level office areas are designed to accommodate 315 pre-wired work stations, central elevator lobby, and 1,200 SF computer room with backup power.
