24. BRIEF DESCRIPTION OF PROJECT AND RELEVANCE TO THIS CONTRACT *(Include scope, size, and cost)*

Yulee Elementary School replaced all existing wood frame classrooms and administrative areas with new permanent buildings. The scope of work also included renovating, expanding and connecting the existing media center, skills and art labs and new cafeteria building to new campus wide central heating and air conditioning plant.



The project included 66,430 square feet of facility at a final construction cost of \$6,348,962 or approximately \$95.57 per square foot including all site work, renovations, additions, new construction, central mechanical plant and \$450,000 for full data technology support with **blown fiber optic media**.

The project provides for 875 student stations at a construction cost of \$8,375.93 per student station. Loose furnishings, computers and monitors were provided separately by the Nassau County School Board.
